#### STATEMENT OF OFFENCE

Causing Financial Loss to the Republic contrary to section 179A(1) of the Criminal Offences Act, 1960 (Act 29)

#### PARTICULARS OF OFFENCE

OSEI ASSIBEY ANTWI (Former Executive Director, NSA), between August 2021 and February 2025 willfully caused financial loss of Five Hundred Million, Eight Hundred and Sixty-One Thousand, Seven Hundred and Forty-Four Ghana Cedis and Two Pesewas (Gh¢ 500,861,744.02) belonging to the National Service Authority, by authorizing payments of allowances to in excess of 60,000 non-existent (ghost) national service personnel.

#### **COUNT TWO**

#### STATEMENT OF OFFENCE

Stealing contrary to section 124(1) of the Criminal Offences Act, 1960 (Act 29)

#### PARTICULARS OF OFFENCE

OSEI ASSIBEY ANTWI (Former Executive Director, National Service Authority (NSA)), on or about 22<sup>nd</sup> August 2023 in the Greater Accra Region dishonestly

appropriated the sum of Three Million, Six Hundred and Twelve Thousand Ghana Cedis (Gh¢ 3,612,000) belonging to the National Service Authority.

Stealing contrary to section 124(1) of the Criminal Offences Act, 1960 (Act 29)

# PARTICULARS OF OFFENCE

OSEI ASSIBEY ANTWI (Former Executive Director, NSA), on or about 11th September 2023 in the Greater Accra Region dishonestly appropriated the sum of Five Hundred and Sixteen Thousand Ghana Cedis (Gh¢ 516,000) belonging to the National Service Authority.

# STATEMENT OF OFFENCE

Stealing contrary to section 124(1) of the Criminal Offences Act, 1960 (Act 29)

# PARTICULARS OF OFFENCE

OSEI ASSIBEY ANTWI (Former Executive Director, NSA), on or about 26<sup>th</sup> October 2023 in the Greater Accra Region dishonestly appropriated the sum of Five Hundred and Sixteen Thousand Ghana Cedis (Gh¢ 516,000) belonging to the National Service Authority.

Stealing contrary to section 124(1) of the Criminal Offences Act, 1960 (Act 29)

# PARTICULARS OF OFFENCE

OSEI ASSIBEY ANTWI (Former Executive Director, NSA), on or about 23<sup>rd</sup> November 2023 in the Greater Accra Region dishonestly appropriated the sum

of Five Hundred and Sixteen Thousand Ghana Cedis (Gh¢ 516,000) belonging to the National Service Authority.

#### COUNT SIX

#### STATEMENT OF OFFENCE

Stealing contrary to section 124(1) of the Criminal Offences Act, 1960 (Act 29)

#### PARTICULARS OF OFFENCE

OSEI ASSIBEY ANTWI (Former Executive Director, NSA), on or about 18<sup>th</sup> December 2023 in the Greater Accra Region dishonestly appropriated the sum of One Million, Thirty-Two Thousand Ghana Cedis (Gh¢ 1,032,000) belonging to the National Service Authority.

#### STATEMENT OF OFFENCE

Stealing contrary to section 124(1) of the Criminal Offences Act, 1960 (Act 29)

#### PARTICULARS OF OFFENCE

OSEI ASSIBEY ANTWI (Former Executive Director, NSA), on or about 14<sup>th</sup> May 2024 in the Greater Accra Region dishonestly appropriated the sum of Two Million, Sixty-Four Thousand Ghana Cedis (Gh¢ 2,064,000) belonging to the National Service Authority.

#### **COUNT EIGHT**

#### STATEMENT OF OFFENCE

Causing Financial Loss to the Republic contrary to section 179A(1) of the Criminal Offences Act, 1960 (Act 29)

#### PARTICULARS OF OFFENCE

OSEI ASSIBEY ANTWI (Former Executive Director, NSA), between January 2022 and December 2024 in the Greater Accra Region willfully caused financial loss of Eight Million, Two Hundred and Fifty-Six Thousand Ghana Cedis (Gh¢ 8,256,000) belonging to the National Service Authority, by authorizing transfers from the Authority's Control Account to e-zwich card no. 1177042059, the property of Osei Assibey Antwi.

#### **COUNT NINE**

#### STATEMENT OF OFFENCE

Money Laundering contrary to section 1(2)(c) of the Anti-Money Laundering Act, 2020 (Act 1044)

#### PARTICULARS OF OFFENCE

OSEI ASSIBEY ANTWI (Former Executive Director, NSA), between January 2022 and December 2024 in the Greater Accra Region knowing that a sum of Eight Million, Two Hundred and Fifty-Six Thousand Ghana Cedis (Gh¢ 8,256,000) diverted into his e-zwich account no. 1177042059 formed part of the proceeds of unlawful activity took possession of the said amount.

#### **COUNT TEN**

#### STATEMENT OF OFFENCE

Causing Financial Loss to the Republic contrary to section 179A(1) of the Criminal Offences Act, 1960 (Act 29)

#### PARTICULARS OF OFFENCE

OSEI ASSIBEY ANTWI (Former Executive Director, NSA), on or about 30<sup>th</sup> September 2022 willfully caused financial loss of Fifty-Five Million Ghana Cedis (Gh¢ 55,000,000) belonging to the National Service Authority, by

authorizing the withdrawal of the said amount from the Project Account No. 1018631542212 for the Kumawu Farm Project without expending it on the Project.

Causing Financial Loss to the Republic contrary to section 179A(1) of the Criminal Offences Act, 1960 (Act 29)

# PARTICULARS OF OFFENCE

OSEI ASSIBEY ANTWI (Former Executive Director, NSA), on or about 20<sup>th</sup> October 2023 willfully caused financial loss of Fifteen Million Ghana Cedis (Gh¢ 15,000,000) belonging to the National Service Authority, by authorizing the withdrawal of the said amount from the Project Account No. 1018631542212 for the Kumawu Farm Project without expending it on the Project.

# STATEMENT OF OFFENCE

Causing Financial Loss to the Republic contrary to section179A(1) of the Criminal Offences Act, 1960 (Act 29)

# PARTICULARS OF OFFENCE

OSEI ASSIBEY ANTWI (Former Executive Director, NSA), on or about 24th January 2024 willfully caused financial loss of Four Million Ghana Cedis (Gh¢ 4,000,000) belonging to the National Service Authority, by authorizing the withdrawal of the said amount from the Project Account No. 1018631542212 for the Kumawu Farm Project without expending it on the Project.

# COUNT THIRTEEN

#### STATEMENT OF OFFENCE

Causing Financial Loss to the Republic contrary to section 179A(1) of the Criminal Offences Act, 1960 (Act 29)

#### PARTICULARS OF OFFENCE

OSEI ASSIBEY ANTWI (Former Executive Director, NSA), on or about 22<sup>nd</sup> March 2024 willfully caused financial loss of Ten Million Ghana Cedis (Gh¢ 10,000,000) belonging to the National Service Authority by authorizing the withdrawal of the said amount from the Project Account No. 1018631542212 for the Kumawu Farm Project without expending it on the Project.

#### COUNT FOURTEEN

#### STATEMENT OF OFFENCE

Causing Financial Loss to the Republic contrary to section 179A(1) of the Criminal Offences Act, 1960 (Act 29)

#### PARTICULARS OF OFFENCE

OSEI ASSIBEY ANTWI (Former Executive Director, NSA), on or about 14th May 2024 willfully caused financial loss of Twenty-Two Million Ghana Cedis (Gh¢ 22,000,000) belonging to the National Service Authority, by authorizing the withdrawal of the said amount from the Project Account No. 1018631542212 for the Kumawu Farm Project without expending it on the Project.
